Draft Minutes of a meeting held on Monday, April 9th, 2018 at 7.30pm in Nympsfield Parish Hall.

18/46 Apologies. Councillors Elizabeth Sturgess (ES) (Chair), Carol Pittaway (CP), David Acton (DA), Jim Dewey (RJD), Lorraine Patrick (LP).

18/47 Public Representation. Peter Tomiac (PT).

18/48 Declarations of Interest. None.

18/49 Minutes of the meeting held on 12th March 2018 were agreed as a correct record of the meeting and signed by the Chair.

18/50 District and County Councillor Reports. None.

18/51 Bus Shelter. DA has spoken to John Gazzard who reported that the tiles on the Bus Shelter had not slipped and were as they should be so no further action required.

18/52 Highways. It was agreed to ask GCC to put up 'no wide vehicle' signs at the top of Blackberry Lane and at the Tinkley Lane crossroads to deter large vehicles from coming down Front St. and Back St.

18/53 Village Maintenance. (i) Lengthsmen. It was agreed to ask the lengthsmen to clear out gullies and ditches, especially opposite Bell Court and on Tinkley Lane opposite Bob Stevenson's house. It was agreed that AM chase up GCC about replacing and repairing the passing place signs on Tinkley Lane. PT reported he was getting a quote for the installation of some picket fencing like that on Selsey Common for Cockadilly and Tinkley Lane. He agreed to ask Adam Reynolds.

18/54 Stagecoach Bus Service. AM reported she had received an acknowledgement from Stagecoach to the letter regarding the new bus stops. DA had also reported a complaint from a parishioner who waited for a bus that failed to turn up.
